RESOLUTION DECLARING THE BID OF STAR SPECIAL CORPORATE SECURITY MANAGEMENT INC., AS THE LOWEST CALCULATED RESPONSIVE BID AND RECOMMENDING THE AWARD OF THE CONTRACT TO THE SAID COMPANY FOR THE PROCUREMENT OF SECURITY SERVICES FOR CY 2014

WHEREAS, the Fertilizer and Pesticide Authority (FPA) posted the Invitation to Bid for the Procurement of Security Services for CY 2014 with the Approved Budget for the Contract (ABC) of Nine Hundred Thousand Pesos (PhP 900,000.00) in "Phil-GEPS" on May 13, 2014 and in conspicuous places at the premises of the FPA for twenty nine (29) days.

WHEREAS, in response to the said advertisement, seven (7) suppliers ordered a copy of the associated components in the posted advertisement in Phil-GEPS but only three(3) suppliers bought the bidding documents .

WHEREAS, the FPA Bids and Awards Committee issued Bid Bulletin No.1 dated May 15, 2014 to inform all the prospective bidders of the schedule of the Pre-Bid Conference.

WHEREAS, a second bid bulletin was issued in connection with the aforesaid procurement project, Bid Bulletin No. 4 dated May 27, 2014, informing all prospective bidders of the results of the conducted Pre-Bid Conference. Among the matters that were discussed are as follows:

- the inclusion of the Tax Clearance in the Class A legal Documents;
- the bid security which will be composed of the bid securing declaration and at least one of the acceptable forms;
- to adapt the amended Omnibus Sworn Statement template as part of the technical documents; and
- the submission and opening of bids which was re-scheduled to June 11, 2014 due to the request of the bidders

WHEREAS, on June 11, 2014, the scheduled opening of bids, the three (3) suppliers namely, Baguio Investigation and Security Agency Inc., Star Special Corporate Security Management Inc. and Phil. Scout Veterans Security and Investigation Agency, submitted their bids.

WHEREAS, the bid of the Phil. Scout Veterans Security and Investigation Agency was disqualified due to the expired Tax Clearance that they submitted.

WHEREAS, the bids submitted by other bidders were found to be substantially complying with respect to the technical and financial specifications:

WHEREAS, the detailed evaluation of bids conducted on June 18, 2014 resulted in the following:

WHEREAS, after careful examination and evaluation of the bid submitted by Star Special Corporate Security Management Inc., their bid was found to be the lowest calculated responsive bid.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- a. To declare the bid of Star Special Corporate Security Management Inc. as the Lowest Calculated Responsive Bid; and
- b. To recommend to the Executive Director of the Fertilizer and Pesticide Authority that the contract for the Procurement of Security Services for CY 2014 be awarded to Star Special Corporate Security Management Inc.
