RELOCATION OF EIGHT (8) CONDENSER UNITS AT THE FPA BUILDING

Approved Budget for the Contract (ABC): PhP 155,000.00

I. RELOCATION OF EIGHT (8) CONDENSER UNITS

A. Scope of Work

- 1. Dismantling of steel base and eight (8) condenser units
- 2. Fabrication of steel platform including applying of epoxy primer
- 3. Installation of steel platform and condenser unit to assign location
- 4. Additional re-piping of copper tubing including wrapping of polyethylene tape
- 5. Installation of additional electrical wiring with flexible hose
- 6. Supply and installation of brand new circuit breakers with enclosure for eight (8) air conditioning units
- 7. Flushing of system with 141B & nitrogen
- 8. General cleaning of condenser units, leak testing and vacuuming
- 9. Charging of Freon 22 for testing and observation
- 10. The relocated eight (8) condenser units must be operational upon completion of work

B. Materials to be used

1. The materials to be used are not limited to the following: copper tube, circuit breakers with enclosure, angular bars, flat bars, Freon 22, Freon 141B, Nitrogen, electrical wires, flexible hose, polyethylene tape, electrical tape, hacksaw blade, silver rod, welding rod, flux, borax, coil cleaner, epoxy paint, thinner, rugs, Dyna bolts, drill bits and paint brush

Terms and Conditions:

- 1. Quotations received in excess of the ABC shall be automatically rejected during its Openina.
- 2. Quoted prices shall have a validity period of thirty (30) days from the date of the submission of auotation.

- 5. All quoted items must be VAT inclusive.
