NOTICE FOR NEGOTIATED PROCUREMENT FOR THE FUEL REQUIREMENT FOR FY 2021 (via Fleet Card Services) - Rebid

1. The **Fertilizer and Pesticide Authority (FPA)**, through the **National Expenditure Program (NEP) for FY 2021** intends to apply the sum of **three million four hundred ninety-eight thousand pesos (PhP 3,498,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for Fuel Requirement for FY 2021 – (via Fleet Card Services) - Rebid. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The FPA now invites bids for **Fuel Requirement for FY 2021 – via Fleet Card Services (Rebid)**. Delivery of the Goods is required for eleven (11) months from the issuance of Notice of Proceed. Bidders should have completed, within **two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to R.A. 5183.

4. Interested bidders may obtain further information from FPA at the address given below during Mondays to Fridays, 8:00 A.M. – 5:00 P.M.
5. Initial negotiations will be done on January 4, 2021, 10:00 A.M. to give equal time and opportunity to all prospective suppliers to discuss the technical and financial requirements of the project to be able to submit a responsive proposal.
6. Final proposals from all suppliers in the initial negotiations must be duly received by the BAC Secretariat at the address below on or before January 12, 2021, 10:00 A.M. All proposals must be submitted together with a valid **Certificate of PhilGEPS Certificate, Mayor’s Permit** and **Annual Business Tax Return** to the FPA-BAC.
