INVITATION TO BID FOR THE PROCUREMENT OF TABLET COMPUTER - REBID

- The Fertilizer and Pesticide Authority (FPA), through the General Appropriations Act of FY 2022 intends to apply the sum of one million pesos (PhP 1,000,000.00 being the ABC to payments under the contract for the Procurement of Tablet Computer – Rebid (ITB-2022-04-01). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The FPA now invites bids for the above Procurement Project. Delivery of the Goods is required within three (3) months from the date of acceptance of the Notice to Proceed. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- Bidding will be conducted through open competitive bidding procedures using a non-discretionary *pass/fall* criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- Prospective Bidders may obtain further information from FPA and Inspect the Bidding Documents at the address given below during Mondays to Fridays, 8:00 a.m. to 5:00 p.m.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on April 5, 2022 from the given address and websites of the Philippine Government Electronic Procurement System (PhilGEPS) and FPA. The cost of Bidding Documents is waived as no printed copy will be provided to the interested Bidders as they must download the said document in the above-mentioned websites.

- Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before April 25, 2022; 10:00 a.m. Late bids shall not be accepted.
