**SUBJECT : DESIGNATION OF AUTHORIZED REPRESENTATIVES IN
TRANSACTIONING LICENSES AND PERMITS OF CONTROLLED CHEMICALS
AT THE PHILIPPINE NATIONAL POLICE (PNP)**

In the interest of the service and in compliance to the provisions of Republic Act No. 9516, otherwise known as the "Codifying the Laws on Illegal/ Unlawful Possession, Manufacture, Dealing in, Acquisition or Disposition of Firearms, Ammunition or Explosives or Instruments Used in the Manufacture of Firearms, Ammunition and Explosives, and Imposing Stiffer Penalties for Certain Violations thereof, and for Relevant Purposes", the following Laboratory Services Division (LSD) personnel are hereby designated as authorized representatives of the FPA in transacting business at the PNP, to wit:

1. **Ms. Ma. Regina T. Yana**, Chemist II – Main Authorized Representative
2. **Mr. Alvin R. Oabel**, Chemist II – Alternate Authorized Representative

As authorized representatives, they will be in-charge in performing the following functions:

- a) Acquire personal clearances and prepare all the necessary documentary requirements needed for the License to Possess Controlled Chemicals and Permit to Purchase and Move Controlled Chemicals;
- b) Apply these license and/or permit to purchase, move, and possess such controlled chemicals under the PNP;
- c) Prepare monthly consumption reports of all the controlled chemicals by the PNP which are being used at the FPA laboratory; and
- d) Perform such other functions needed to ensure that the License to Possess Controlled Chemicals are renewed on time and Permit to Purchase and Move Controlled Chemicals are secured prior to the delivery of the controlled chemicals.

As such, reimbursement of the expenses incurred from PNP related transactions are hereby authorized subject to the usual government accounting and auditing rules and regulations.

This Order shall take effect immediately and shall supersede all other Orders that are inconsistent herewith.
