In the interest of service and pursuant to the provisions of Malacañang Administrative Order No. 135, s. 2005, Congress and Senate Joint Resolution (JR) No. 4, s. 2009, PSLMC Resolution No. 4, s. 2002, DBM Circular No. 2006-1, s. 2006, and COA Resolution No. 2006-009, s. 2006 the Employees' Organization - Management Consultative Committee (EOMCC) is hereby created and composed of the following:

The EOMCC shall perform the following functions, in addition to their current duties and responsibilities, to wit:

- monitor the implementation of the provisions of the collective negotiation agreement (CNA) upon approval by the parties;
- monitor and resolve any controversy arising from the interpretation and enforcement of the existing CNA;
- discuss and resolve any policy changes on matters pertaining to or affecting the terms and conditions of employment;
- determine if FPA is qualified for the grant of CNA incentive based on compliance with the requirements set by DBM and COA; and
- recommend appropriate courses of action to a higher authority.

As such, all expenses to be incurred in the conduct of EOMCC activities shall be charged against FPA regular funds, subject to existing government accounting and auditing rules and regulations.

This Order shall take effect immediately and supersedes previous orders inconsistent herewith and shall remain enforced unless otherwise revoked in writing.
