EFFECTIVITY OF THE REVISED FPA CITIZEN'S CHARTER ON THE

EXTERNAL SERVICES OF THE FERTILIZER REGULATIONS

Pursuant to Department Circular No. 6, Series of 2023, otherwise known as the "Harmonization of Terms and Streamlining of Requirements for Authorization and Recognition Under the Regulatory Jurisdiction of the Department of Agriculture", the requirements for License to Operate (LTO) as Fertilizer Handler have been harmonized to include the following documents:
