SUBJECT: AMENDMENT TO THE FPA MEMORANDUM CIRCULAR NO.01 SERIES

OF 2010 ON THE DOSAGE OF CHLOROTHALONIL 720SC FOR THE USE IN BANANA PRODUCTION FOR THE CONTROL OF BLACK SIGATOKA

The maximum dosage of Chlorothalonil 720 SC and the maximum number of cycles were stated in the FPA Memorandum Circular No. 01 Series of 2010 as 25.5 kg. active ingredient /ha/ year and maximum number of cycles /year.

In the pursuit of the local efficacy and supervised residue trials currently being conducted to satisfy the requirements for the full registration of the said product, the limitations of the afore-mentioned dosage and number of cycles were brought to FPA's attention. Upon review of the pertinent data, it was found that the said dosage and number of cycles were inadvertently stated as such. This circular shall, henceforth, establish the corrected dosage and number of cycles as follows:

Maximum Dosage: "25.92 kg active ingredient / ha / 90-day banana fruit cycle"

Maximum Cycles/ ha / 90-day banana fruit cycle :

0.72 kg.	ai/ ha or	1.0 L	product / ha	 35
1.44 kg.	ai/ ha or	2.0 L	product / ha	 18

The revised Directions for Use for the said product is, therefore, as follows:

Dosage	Max Cycles/ ha / 90-day fruit cycle
0.72kg ai/ha or 1.0L pdt./ha	35
1.44kg/ai/ha or 2.0L pdt./ha	18
Max. dosage for both rates: 25.9	2 kg ai / ha / 90-day banana fruit cycle

This circular takes effect immediately and supercedes previous orders inconsistent herewith.
