FPA XII COMMITS TO END CORRUPTION IN THE **AGRI-SECTOR**



It also endorses to applications for License to Operate for Importer/Distributor; Distributor; Importer End-user; Manufacturer/Processor/Formulator; Exporter; Indentor and Repacker to FPA Central Office based in Quezon City.

FPA VII PROVIDES ASSISTANCE IN THE IMPLEMENTATION OF RICE RESILIENCY PROJECT


SEPTEMBER 22, 2020
