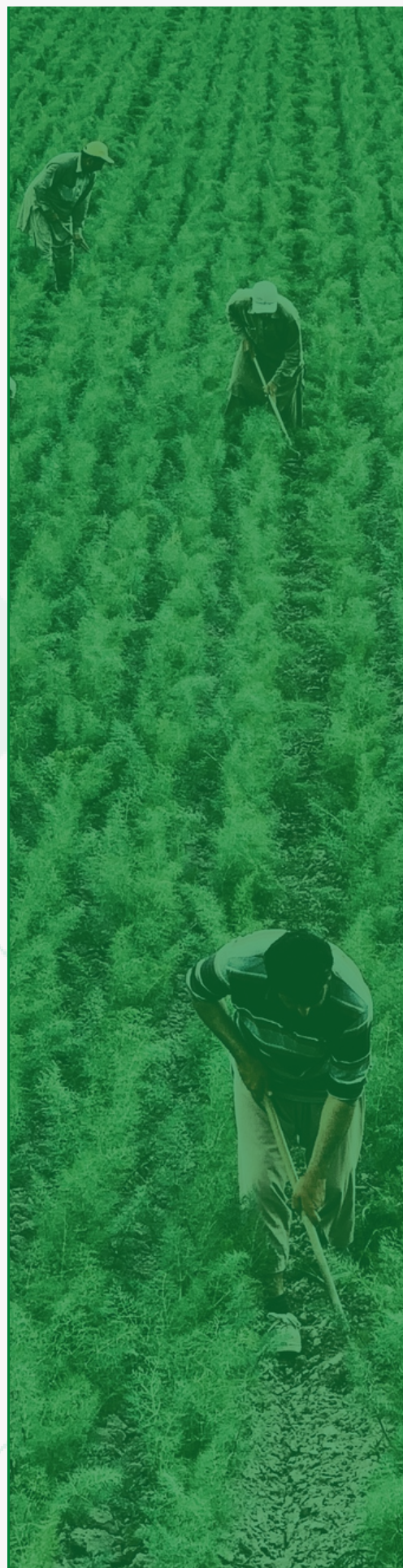

CORDILLERA ADMINISTRATIVE REGION



FPA RFU CAR - APRIL 21, 2023

TRINIDAD, BENGUET – FPA CAR Provincial Officer monitored Experimental Use Permits in Balili, La Trinidad.

FPA-CAR monitors 100% of the approved EUPs to assure compliance of handlers and researchers for the necessary requirements on the registrations of agricultural products (fertilizer and pesticide). The purpose of the trial is to generate bio-efficacy and residue data for product registration.

FPA RFU XI - APRIL 3-4, 2023

PANABO CITY & DAVAO CITY - Four (4) Extrusion Plants that manufacture pesticide-impregnated polybags used for the banana industry were inspected on April 3-4, 2023.

The inspection was conducted to ensure quality standards and safe operating procedures at the extrusion plant. The team also collected samples of the finished product from the extrusion process (polybag) for further laboratory analysis. The findings during the inspection will serve as a pre-requisite for renewal of their License to Operate (LTO) as Extruder with FPA.

FPA RFU XII - APRIL 4-5, 2023

This is in line with the letter released by FPA, dated February 27, 2023, to pull out and relabel those herbicides with erroneous product registration numbers as corrective actions.

FPA RFU XII - APRIL 28, 2023

SOUTH COTABATO – Fifteen (15) establishments were monitored as the Fertilizer and Pesticide Authority (FPA) Region 12 conducted a clean-up drive operation in different municipalities of South Cotabato and Sultan Kudarat on April 18-20, 2023.

During the operation, the team found 11 fertilizer and pesticide (f/p) handlers without a license to operate and trained Accredited Safety Dispenser (ASD) personnel, which resulted in the issuance of Notice of Violations (NOVs). Officers then invited the violators to attend the upcoming ASD training on May 17, 2023, in Tacurong City.

In addition, 46 fertilizer products and 94 pesticide products were inspected to assure the farmers of safe and standard products catered in the market.

The team also distributed triple-rinse posters to all handlers in the area as part of the agency's campaign on empty pesticide container management.

Further, occupational health monitoring and risk appraisal assessment were conducted in one banana plantation in Lake Sebu to ensure the enforcement of policies on safety in accordance with Department of Labor and Employment (DOLE) regulations.

This activity aims to enforce safety and regulatory practices and strengthen the monitoring and inspection of F/P handlers, products, and warehouses.

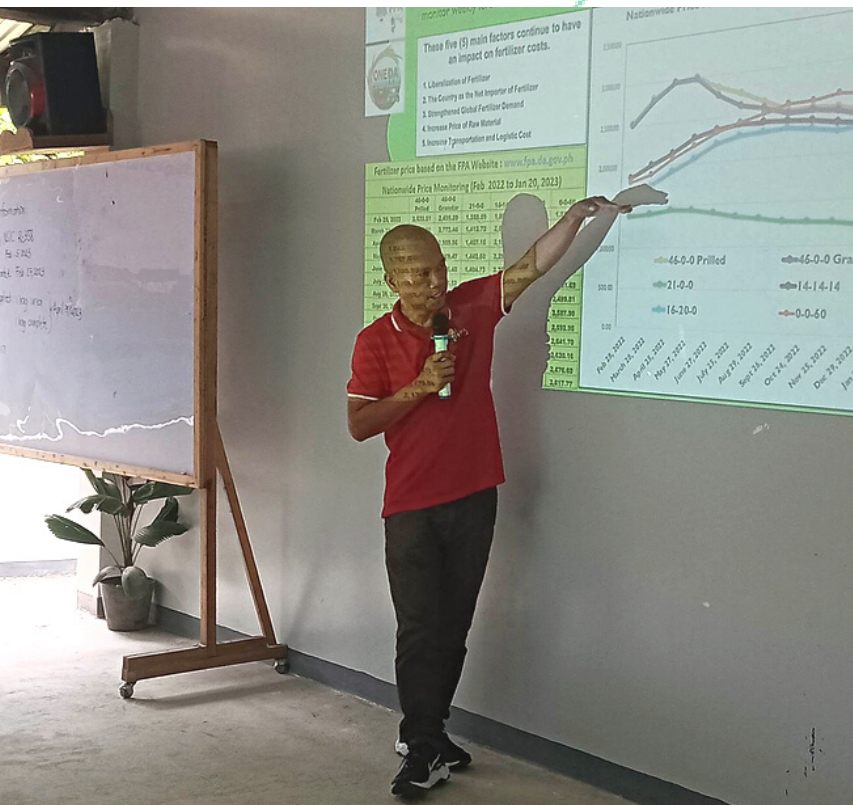
EASTERN VISAYAS
