ILOCOS REGION



FPA RFU I - NOVEMBER 29, 2023

FPA Ilocos, led by Regional Officer (RO) Joseph Andre John O. Martinez, inspected the manufacturing plant of Syngenta Philippines Inc. on the Occupational Health Program and Technical Safety being imposed by their company.

The said inspection is a requirement prior to the issuance of a License to Operate as a Pesticide Imported/End-User. The company was found to be compliant with the standards set by FPA.

The activity was conducted on November 29, 2023, in Binalonan, Pangasinan.

CENTRAL LUZON REGION



FPA RFU III - NOVEMBER 21, 2023

FPA Central Luzon conducted a Clean-Up Drive (CUD) operation on November 21, 2023, in the Municipality of La Paz and Tarlac City, Tarlac.

The CUD operation, spearheaded by Regional Officer (RO) Romeo Val R. Suguitan, Jr., was conducted to enforce safety and regulatory practices and strengthen the monitoring and inspection of fertilizer and pesticide handlers, products, and warehouses.

CALABARZON-MIMAROPA



FPA RFU IV - NOVEMBER 14, 2023

FPA Region IV conducted an information campaign on safe and Judicious use of Pesticide in the municipality of Mogpog, in the province of Marinduque last November 14, 2023.

The team discussed the Fertilizer and Pesticide Authority Briefer, the General Information on Pesticides, safe handling, use and storage of pesticides and recognition of pesticide poisoning. Ms. Suzettie M. Alcaide, Supervising Agriculturist of FPA region IV, reminded the farmers to practice safe handling and use of pesticides as well as to produce safe agricultural commodities. She emphasized the need to be more cautious in buying not only pesticide but also fertilizer products and to buy only from dealers with FPA license.

A total of thirty two (32) vegetable farmers from the different barangays of the said municipality participated.

The activity was made possible through the assistance of the Municipal Mayor of Mogpog, Marinduque, Hon. Augusto Leo Livelo through the OIC Municipal Agriculture Officer Ms. Marneli R. Nuñez, Bayer CropScience Philippines, Rainbow Agrosciences Philippines Inc., Leads Agriventures Corporation and Agrispecialist Inc.

WESTERN VISAYAS REGION

FPA RFU VI NOVEMBER 14, 2023

FPA Western Visayas conducted a spot checking of licensed handlers and random weighing of fertilizers at Kalibo, Aklan last November 14, 2023.

The FPA VI personnel randomly weighed all the brands of fertilizers and validated the product label at the distributors warehouse storage. The licensed establishment passed the standards of the FPA and no underweight fertilizers were observed.

FPA RFU VI NOVEMBER 20, 2023

FPA Western Visayas conducted an inspection of the remotely piloted aircraft system for use as drone spraying on November 20, 2023, in Bacolod, Negros Occidental.





FPA RFU VI NOVEMBER 21-23, 2023

FPA Western Visayas validated the Agri/Aqua Self-Monitoring Report (ASMR) in line with the issuance of Safe Re-Use of Wastewater last November 21-23, 2023.

Three (3) cities from Negros Occidental (San Carlos City, Victorias City, La Carlota) were inspected.

FPA RFU VI NOVEMBER 22-24, 2023

FPA western visayas conducted random weighing, product validation and warehouse inspection at Escalante, Bacolod City, San Carlos City, Negros Occidental on November 22-24, 2023.

Eleven (11) establishments were subjected to a surprise inspection. One of the inspected establishments was given a notice of violation in relation to unauthorized repacking of fertilizer, no warehouse registration and non compliant to good warehouse keeping.

The said establishment was given fifteen (15) days for compliance and shall undergo ASD training.





CENTRAL VISAYAS REGION

FPA RFU VII NOVEMBER 10, 2023

Provincial Officer Jesus Muring conducted a random fertilizer sampling of the product TAKADA 14-14-14 at Jagna Municipal Agriculture Office, Lubcanan Tubod Monte, Jagna, Bohol last November 10, 2023.

The Department of Agriculture Regional Field Office VII (DA-RFO VII) requested the random sampling for confirmatory analysis.

The said fertilizer is part of the Fertilizer Distribution Voucher Program of the Department of Agriculture.



FPA RFU VII NOVEMBER 29, 2023

Provincial Officer (PO) Sunday Flores conducted a bioefficacy field test monitoring at the Department of Agriculture Regional Field Unit 7, MES Compound, Maguikay, Mandaue City, Cebu, on November 29, 2023.

Before registering new products, a bioefficacy test trial is required to ensure the quality of fertilizer products. Moreover, all experiments are only conducted by FPA accredited researchers, and FPA officers closely monitor all experiments to ensure that all protocols for efficacy testing are met.

DAVAO REGION





FPA RFU XI NOVEMBER 9-10, 2023

The FPA Davao Region conducted a clean-up drive at the Municipalities of Kapalong, Talaingod, Sto, Tomas, and B.E. Dujali, Davao del Norte on November 9-10, 2023.

A total of seventeen (17) fertilizer dealer and dealer-repacker establishments were inspected.

FPA RFU XI NOVEMBER 20, 2023

Regional Officer (RO) Marrisa Napalit and Provincial Officer (PO) Cheery Agrade conducted a pesticide extrusion plant post-licensing inspection on November 20, 2023, at Carmen, Davao del Norte.





FPA RFU XI - NOVEMBER 21, 2023

The FPA Team conducted a Banana Plantation inspection which highlights the ocular inspection of its chemical mixing facilities, the functionalities of the equipment, the disposal of excess waste, the safety of the chemical handlers during chemical operations at the Packing House, and more. The team also inspected the warehouses of fertilizers and pesticides, their good housekeeping practices, and their order. In general, FPA audits its major functions such as the Organizational Aspect, Occupational Health, Industrial Hygiene, Farm, Safety and Security, and Environmental Protection.

As part of their requirements for licensing with FPA, these inspection reports will serve as a pre-requisite for their license to operate as Institutional User, and Warehouse of Fertilizer and Pesticide.

FPA RFU XI NOVEMBER 23, 2023

The FPA Davao Region conducted a Banana Plantation inspection at Nabunturan, and, Maco, Davao de Oro on November 23, 2023.

The ocular inspection of the plantation's chemical mixing facilities, the functionalities of the equipment, the disposal of excess waste, the safety of the chemical handlers during chemical operations at the Packing House, and more were highlighted. The team also inspected the warehouses of fertilizers and pesticides, their good housekeeping practices, and their order.

The inspection report serves as a prerequisite for a license to operate as an Institutional User, and Warehouse of Fertilizer and Pesticide.





SOCCSKSARGEN



FPA RFU XII NOVEMBER 3, 2023

As part of the requirement for product registration, FPA SOCCSKSARGEN conducted a field validation on the approved EUP on November 3, 2023, at Tupi Research Station, Tupi South Cotabato.

The activity aims to validate and verify whether the efficacy evaluation of Crop Vigor Foliar Fertilizer follows the approved EUP #4092 and test protocol.

FPA RFU XII - NOVEMBER 20-22, 2023

Fourteen (14) fertilizer and pesticide handlers were inspected during a Clean-Up Drive (CUD) operation in the Municipalities of Maitum, Kiamba, Malungon, Alabel, Malapatan, Sarangani Province, and in General Santos City on November 20-22, 2023.

Of the 14 handlers, six (6) establishments were given Notice of Violations (NoVs) for not having a License to Operate (LTO) as a dealer and for selling expired and unregistered f/p products.

Moreover, a total of 270 f/p products were inspected. Stop Use, Move, and Sale (SUMS) orders were issued to three (3) products that were found unregistered. Other activities during the CUD operation include follow-up filed cases on PD 1144 at Malungon Police Station and Municipal Circuit Trial Court, Alabel, Sarangani.

OIC – Regional Officer Cherubin M. Alonzo led the operation along with Provincial Officers (PO) Maricel P. Tabigue, Jennie M. Basilio, and Joey B. Pascua.





FPA RFU XII - NOVEMBER 29, 2023

As part of the ongoing Food and Agriculture Organization of the United Nations project, 16,000 bags of urea and 8,000 bags of complete fertilizers were procured. The fertilizers will be distributed to farmer-beneficiaries in Maguindanao del Sur, Maguindanao del Norte, and Lanao del Sur, including the Special Geographic Areas (SGA).

In line with this, FPA SOCCSKSARGEN inspected and collected fertilizer samples of the procured fertilizers on November 29, 2023, at Nuro UPI, Maguindanao del Sur.

As an agreed protocol with the MAFAR-BARMM, fertilizers should be inspected, sampled, and analyzed before the delivery/distribution at the supplier's warehouse. Further, a confirmatory second inspection of the fertilizers will be conducted at the delivery/drop-off points. This is to ensure that the fertilizers that will be distributed pass the quality standards set by the government.

The said project is funded by the Japanese government and jointly implemented by the Ministry of Agriculture, Fisheries and Agrarian Reform of the Bangsamoro Autonomous Region in Muslim Mindanao (MAFAR-BARMM).

FPA RFU XIII - NOVEMBER 13-15, 2023

"A Clean-Up Drive Operation was conducted by FPA Caraga in the City of Bislig and Municipalities of Hinatuan, Tagbina, Barobo, Tago, and San Miguel in Surigao del Sur last November 13-15, 2023. The activity was conducted to check if the fertilizer and pesticide products and good housekeeping practices were being observed."

The said training was designed to educate all safety dispensers in the province on the proper use and handling of agricultural inputs.

The participants were evaluated through a series of pre-tests and post-tests, which will be used as a basis for FPA's Accredited Safety Dispensers.

Fifty-five (55) participants from the provinces of Tarlac, Nueva Ecija, Pampanga, and Bulacan attended the activity.

The FPA-RFU IV team, headed by Ms. Suzettie M. Alcaide, trained the participants with direct access to farmers on proper information and handling of inorganic agricultural inputs.

A total of thirteen (13) participants from the municipalities of Marinduque and nearby provinces completed and passed the training.

The training is part of the primary requirements in securing a dealership license from the Fertilizer and Pesticide Authority.

SOCCSKSARGEN




FPA RFU XII - NOVEMBER 23, 2023
