Pursuant to the directive of President Rodrigo Duterte and Department of Agriculture Secretary William Dar toward the elimination of corruption in the bureaucracy, FPA Executive Director Wilfredo Roldan and OIC Deputy Executive Director for Pesticide Romirose Padin, led the signing of the Pledge of Good Governance and Zero Corruption in the agency on September 30, 2020, at the Central Office.

The event was participated by the other members of the FPA Management Committee (ManCom), as well as the different FPA Regional Field Units, who expressed their full support and joined the event through the simultaneous signing of the pledge via Google Meet.

During his speech, Director Roldan said that the values of transparency, accountability, and efficiency are pillars that will continue to guide FPA and the rest of the government in the quest for good governance.

On the same day, the ManCom members signed the Manifesto of Support for the Passage of the Freedom of

FPA explains farm inputs dispenser's role to clients



LA TRINIDAD, Benguet, Sept. 9 (PIA) - - The trained fertilizer and pesticide dispenser is expected to guide the buyer in acquiring the appropriate and affordable farm inputs for agricultural produce who is likened to a physician issuing a prescription of medicine or supplement to a patient.

This is how Fertilizer and Pesticide Authority (FPA) Regional Coordinator Reynaldo Segismundo describes the role of Accredited Safety Dispenser (ASD) of fertilizer and pesticide handling towards their customers.

The ASD's role is as important in guiding and assisting the farmer with the prescribed farm input for vegetable or ornamental plants. ASD

training is a pre-requisite in securing FPA license to operate as a dealer.


FPA mandates that all licensee or applicants for fertilizer or pesticide dealership must have at least two (2) ASD under their employ who must be trained in advising or assisting buyers of fertilizers/ pesticides on its safe handling, storage and and judicious use.

"A trained ASD is expected to ask the buyer's concerns before releasing any item not only for the sake of Segismundo explained. selling," The buyer needs to be clarified of the item labels which include the active ingredients and descriptions, handling, dosage, and warranty.

Rowena Billig, FPA Provincial Officer for Benguet and Baguio, said FPA holds ASD trainings for fertilizer and pesticide handling at least twice a vear.

In the training, ASDs are taught on the categories of fertilizers and pesticides. pesticide information and soil and management, management, fertilizer handling and management, FPA rules and regulations, pesticide first aid management, exposure to pesticides, types of pesticide poisoning, signs and symptoms of poisoning among others. FPA initiates online accreditation trainings, exams



The Fertilizer and Pesticide Authority transitioned from face-to-face to online conduct of accreditation trainings and examinations since August 2020, in view of the suspension of mass gathering pursuant to IATF Omnibus Guidelines dated May 22, 2020.

Conducting accreditation trainings is necessary for individuals who wish to become Accredited Responsible Care Officers (ARCO), Certified Pesticide Applicator (CPA), Fertilizer and Pesticide Researchers, and Accredited Safety Dispensers (ASD). They will be issued an accreditation ID after passing the required examination and submission of essential requirements.

Through online platforms like Zoom, MS Teams, among others, the FPA, in coordination with the FPA Accredited Training Associations (FATA), has started conducting the required training course and symposium.

As of November 2020, ____ participants attended the online

accreditation trainings, which can be broken down as follows:

ARCO, ____ CPA, and ___ FP
Researchers. On the other hand,
 __ individuals attended online symposia which is necessary for the renewal of their accreditation licenses.

Immediately after attending the training, the participants have taken the examination held in the FPA Regional Offices except in BARMM. For examinees from NCR and adjacent provinces, exams were taken at the FPA Central Office in Quezon City.

The updated schedule of online trainings and symposia can be viewed at: https://bit.ly/38ZGGht Interested individuals shall coordinate directly with the FATA for the registration requirements and reservation of slots.

Five training associations are currently registered under FPA: The Philippine Association of Certified Pesticide Applicators (PACPA), PMCP Foundation Inc., the Philippine Association of Entomologists, Inc. (PAE), the Philippine Association of Professional Fumigators, Inc. (PAPFI) and the Kapisanan ng mga Pest Control Operators sa Pilipinas, Inc. (KAPESCOPI).

Moreover, the Field Operations Coordinating Unit (FOCU) conducted for the first time the online Accredited Safety Dispenser (ASD) training on August 12, 2020. ____ individuals have already attended the online ASD trainings conducted.

Meanwhile, the Regional Field Units resumed facilitating ASD trainings while observing public health emergency protocols, when quarantine restrictions have been eased in their respective locations. Attendance to ASD trainings is a pre-requirement for individuals or business entities applying for License to Operate (LTO) as FP Dealer.

FPA assures quality fertilizers for **RRP** farmer-beneficiaries



The Fertilizer and Pesticide Authority supports the Rice Resiliency Program of the Department of Agriculture (DA) by providing technical assistance necessary to assure quality fertilizers intended for rice farmer-beneficiaries.

Starting May 2020, the FPA was tapped by DA to assist the latter in ensuring that fertilizers pass the quality standards through sampling of urea and 14-14-14 fertilizers, laboratory analysis, ocular inspection of warehouses, and the proper transport and storage of these inputs. Behind this effort are the FPA Regional Field Units who worked closely with the DA Regional Field Offices and Local Government Units (LGUs).

The FPA Field Units also continues to conduct monitoring and enforcement activities among agricultural suppliers amid the pandemic, in compliance with the DA Memorandum Order Number 26 Series of 2020.

RRP includes the distribution of inbred and hybrid rice seeds with fertilizers to both rainfed and irrigated areas, on top of the existing Rice Competitiveness Enhancement Fund (RCEF), and support to inbred and hybrid farmers under the National Rice Program (NRP).

The project has three components wherein the distribution of fertilizers is covered under the second and third components which are the Expanded Inbred Rice Production and the Expanded Hybrid Rice Production, respectively.

The DA explained that the RRP farmer-recipients will receive seeds according to the size of their farmland, and fertilizers, at two bags per hectare (ha) for inbred and three bags/ha for hybrid areas.

Secretary Dar said that the use of quality seeds and appropriate fertilizers would help in achieving high productivity in rice.







FPA reminds public to be vigilant in buying fertilizer, pesticide products online

The Fertilizer and Pesticide Authority warns the public of online sellers and traders who do not have a legitimate license from the Authority and whose products are unregistered, as required by Presidential Decree 1144, and the Fertilizer and Pesticide Regulatory Policies and Implementing Guidelines.

"For them to be assured of safe and effective agricultural inputs, buyers should patronize only FPA registered fertilizer and pesticide products being sold by our licensed dealers," Executive Director Wilfredo Roldan said.

In the Memorandum Circular No. 17 issued by the Agency on August 13, the public was advised to verify registration and licenses in the list of handlers and registered products posted on the FPA website, https://fpa.da.gov.ph

The said document also explained that relevant information such as license and registration numbers, raw materials, and country of origin shall be prominently

displayed in the packaging/bag/bottle. These are information being required by FPA among industry stakeholders in their product labels and implementation of Product Stewardship Programs.

As such, the public should also avoid products that are smuggled, underweight, expired, and does not conform standards.

To encourage wide dissemination of such campaign, the FPA seeks the cooperation from industry stakeholders including dealer's associations or cooperatives. The FPA Field Units shall also integrate these reminders in their conduct of information, education, and communication (IEC) campaigns.

The public may report unscrupulous sellers and unregistered products being distributed to any of the FPA Field Units through email and telephone numbers listed on the FPA website.

DA, FPA conduct join inspection of fertilizers in Davao City

The Department of Agriculture Regional Office 12 through the leadership of Regional Executive Director Arlan Mangelen conducted a joint ocular inspection together with the representative from Fertilizer and Pesticide Authority (FPA) 12 and staff from FPA-11 at the Moderntime Enterprises, Inc. warehouse in Lanang, Davao City.

The purpose of the team is to monitor the availability of stocks and conduct a random sampling of fertilizer particularly the procured imported granulated urea from Egypt which will be subject to laboratory analysis.

The said fertilizers will be used for the Rice Resiliency Program (RRP) of the Department of Agriculture. (DA RFO XI)
