



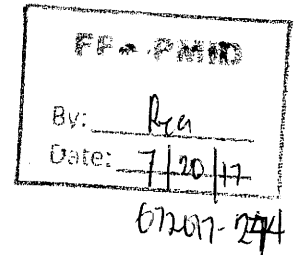

In view of the processing and issuance of license by the Fertilizer and Pesticide Authority (FPA), please be informed that starting August 2017, all licenses to be issued by the Pesticide Regulations Division (PRD) shall indicate a permanent license number on a per company basis for ease of recording and tracking with the following codes, to wit:
